



Kentuck Knob COVID-19 Safety Policy

Revised: Tuesday, February 16, 2021

With Pennsylvania Governor Tom Wolf's announcement that Fayette County has moved into the "green" phase as of June 5, 2020, Frank Lloyd Wright's House on Kentuck Knob is proud to be partnering with museums and cultural institutions throughout Southwestern Pennsylvania that are committed to prioritizing the health and safety of our visitors and staff as we reopen to the public.

Overview

1. Kentuck Knob will remain open to the public with a reduced visitor capacity, physical distancing measures in place, temperature checks, and mandatory wearing of masks.
2. Kentuck Knob will monitor updates from state and local government officials, as well as evolving recommendations from the CDC (Centers for Disease Control and Prevention) regarding best practices for safely operating a business during the COVID-19 pandemic.
3. Kentuck Knob aims to expand offerings to maximize visitor experiences at Kentuck Knob while maintaining and/or increasing safety measures.

Purchase Tickets in Advance

To manage our occupancy and prevent overcrowding, tickets for all guided house tours must be purchased in advance.

Personal Protective Equipment/Masks

As recommended by the CDC, masks must always be properly worn over the mouth and nose while on Kentuck Knob property. Disposable paper masks will be available to visitors who did not bring their own masks. No person can participate in a guided house tour without wearing a mask.

Physical Distancing

Guests will be advised to practice physical distancing by standing at least six (6) feet away from other groups of people not traveling with them while standing in lines, browsing the Gift Shop, and participating in guided house tours.

Public Restrooms

Public restrooms at Kentuck Knob are cleaned by our maintenance staff once per day. Visitors should use caution when touching surfaces in the restrooms and thoroughly wash their hands before leaving the facilities.

Signage will advise visitors to use the public restrooms one person at a time.

Visitors Center and Gift Shop

To minimize the time guests spend inside Kentuck Knob's Visitors Center, tours (guided and self-guided) must be reserved ahead of time via the Kentuck Knob website or by phone at (724) 329-1901.

Non-invasive, thermal temperature checks will be made of each guest upon arrival at the Visitors Center. Any person displaying a temperature over 100°F will be asked to sit outside the Visitors Center for ten (10) minutes before a secondary temperature check is made. Any person confirmed to have a body temperature over 100°F will not be allowed to participate in a tour (guided or self-guided) of Kentuck Knob and will be directed towards appropriate medical care.

After checking in at the front desk, guests will be directed to wait outside the Visitors Center for their designated tour to begin.

Guests are encouraged to shop for gifts and souvenirs after their tour is finished. Disposable nitrile gloves will be provided to guests inside the Visitors Center upon request.

Hand sanitizing stations are available to guests inside the Visitors Center.

Signage throughout the Visitors Center will remind guests of physical distancing guidelines and mask or face covering usage.
